# MINUTES VILLAGE OF CRETE PRESIDENT AND BOARD OF TRUSTEES MEETING August 13, 2018

#### **REGULAR BOARD MEETING:**

President Michael Einhorn called the regular board meeting of the President and the Board of Trustees of the Village of Crete to order on Monday, August 13, 2018 at 7:00 pm in the municipal building at 524 W. Exchange Street, Crete, Illinois. President Einhorn led those assembled in the Pledge of Allegiance to the Flag.

On a roll call by Village Clerk Deborah Bachert the following were present: Trustees Holly Milburn, Doris Harmon-Warren, Stephen Johnson and Mark Wiater and President Michael Einhorn. Trustees Steve Beaudoin and Ray Harley were absent. A quorum was present.

President Michael Einhorn

- 1. Attended the Bulldogs 50<sup>th</sup> Anniversary Celebration on Saturday, August 11<sup>th</sup>. There were approximately 200 people in attendance at HITS Balmoral Park. The Bulldogs organization has become a legendary institution in the Crete area, serving proudly as a group that prides itself in helping to teach the disciplines of not only football but character building and positive values.
- 2. Announced Main Street through the Village limits is slated to be repaved by the State within the next four years. Along with this improvement, the bridge over the creek just south of the viaduct will also be removed and replaced.
- 3. Roads Department will have funds to curb work/planning yet this fall due to the funds being received by the sales tax ½ percent increase which is dedicated to supporting road maintenance. Paving will be done in 2019.
- 4. The iron removal program has had all financial information submitted to the State. The project will be delayed at least 6 months due to unforeseen issues.
