I further affirm that the organization will maintain records regarding said raffle(s) in accordance with Section 6 of the Raffles Act (230 ILCS 15/6) and shall furnish to the Village of Crete documentation evidencing the organization's gross receipts, expenses and net profits from each raffle and the distribution of net proceeds itemized as required under Section 6, within thirty (30) days of the completion of the raffle. If a license is valid for more than thirty (30) days, the report shall be made monthly.
